

KCKPS Denied Opportunity to Raise Standards for Students

The Kansas City, Kansas Public Schools (KCKPS) has learned that the United States Department of Education (USDOE) plans to deny a portion of the district's request to raise standards for its students. In August, the district applied for a waiver from the Kansas Approved Accountability Plan from USDOE, in order to implement a more rigorous assessment system aligned with national standards, which would ensure that all students graduate prepared for success in college and careers.

The district's waiver request sought to substitute the Educational Planning and Assessment System (EPAS) family of assessments (which includes the ACT), along with the **NWEA Measures of Academic** Progress (MAP), for the Kansas State Assessment. USDOE has indicated that it will approve the request to use the EPAS assessments for grades 8-12, but will reject the request to use the MAP for grades 3-7.

"This news is devastating to our system, and to our students," said **Dr. Cynthia Lane,** superintendent of schools. "It is unbelievable to me that we would be denied the chance to raise academic standards, and to administer an assessment that contains the rigor that our students deserve."

Currently, students across the state of Kansas are required to take the Kansas Assessment. Unfortunately, numerous students who score proficient on the state assessment arrive at college unprepared for college-level work. These students must then pay to take developmental classes that do not count toward college graduation.

"The district has a goal that all students graduate ready for college and careers, and that at every level, students are on-track and on-time for success," Lane said. "The Kansas assessment is not rigorous enough to guarantee that our students are on-track with where they need to be. We have asked to raise standards for

our students by administering the MAP, which is a more rigorous assessment, and USDOE is telling us 'No!'"

KCKPS is not the only district in Kansas that has applied for a waiver. McPherson (USD 418) and Clifton-Clyde (USD 224) have also sought similar waivers, in order to be able to raise academic standards for their students. They will also be impacted by the USDOE decision.

"We will not allow this decision to affect our expectations for our students," Lane said. "It may mean that they are forced to take an extra unnecessary series of tests, but we will continue to focus on our own higher standards."

The district will administer both the MAP and Kansas Assessment this spring. The Kansas Department of Education has agreed to extend the testing window for an extra two weeks, given the late notice from USDOE.
